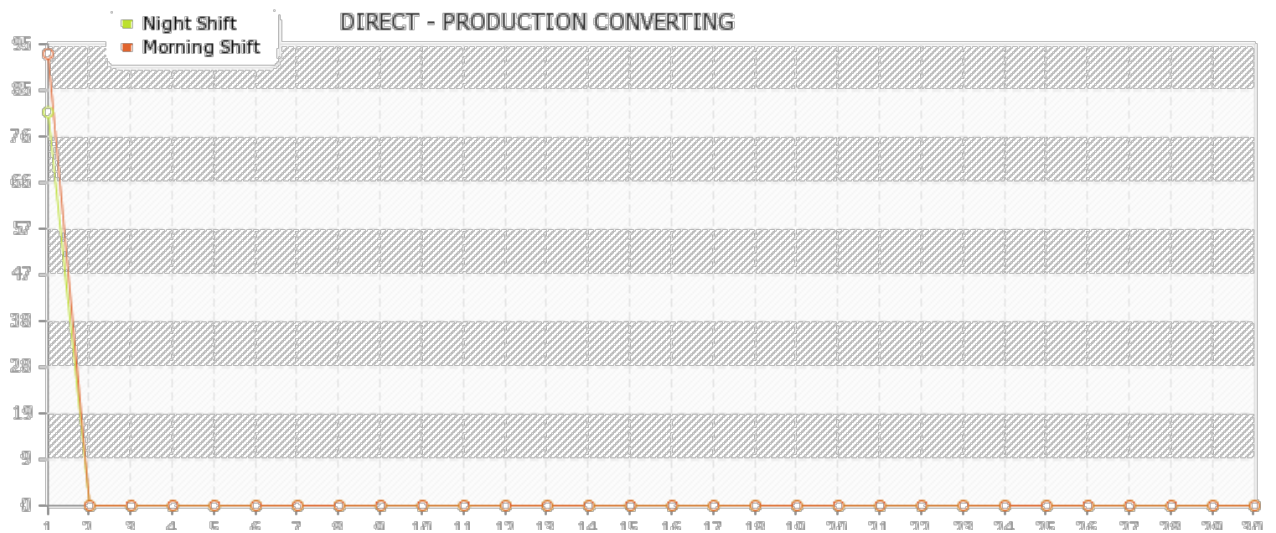

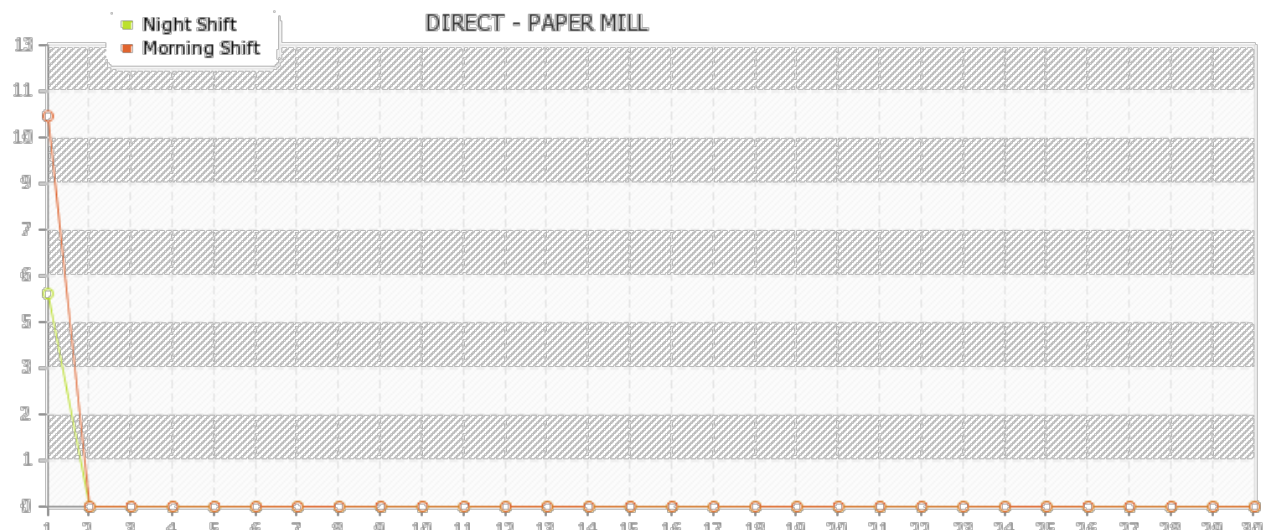

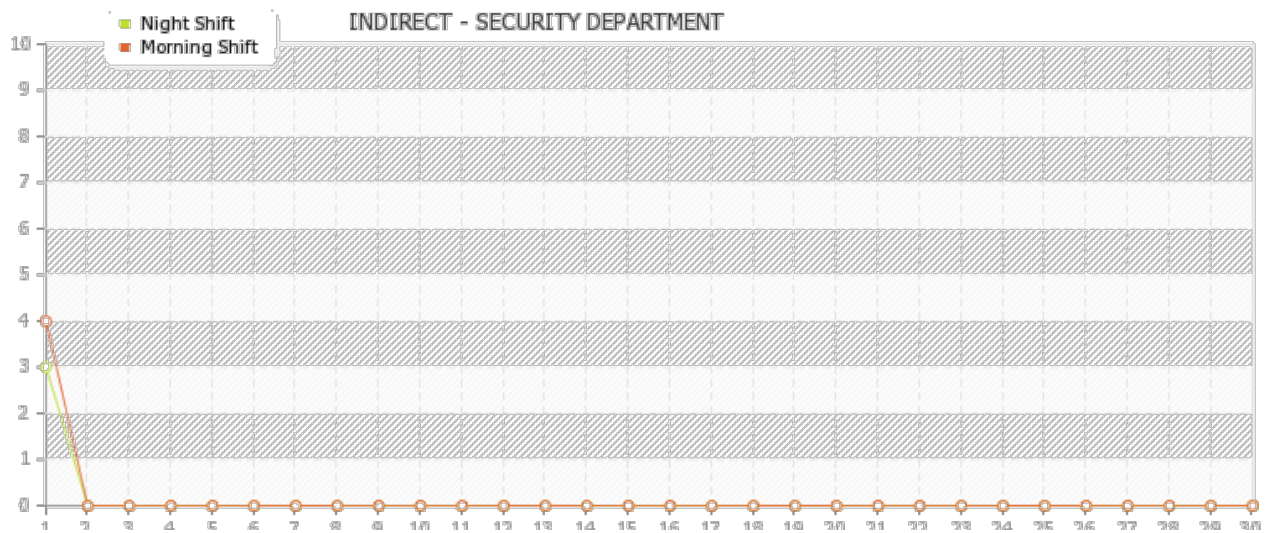


Monthly Attendance for Subang DIRECT - PAPER MILL

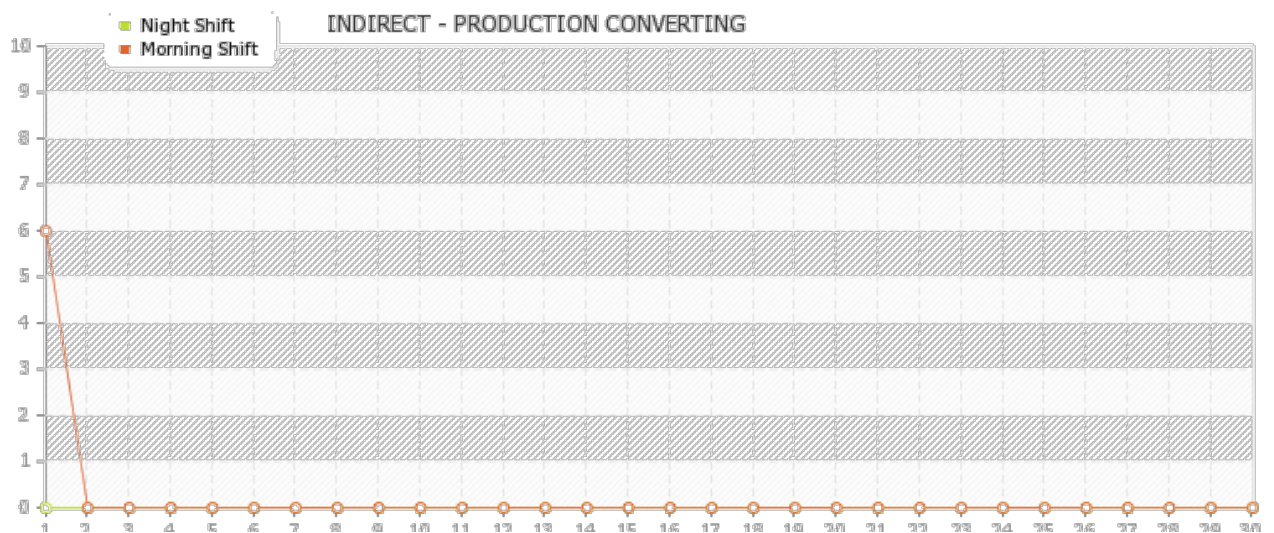

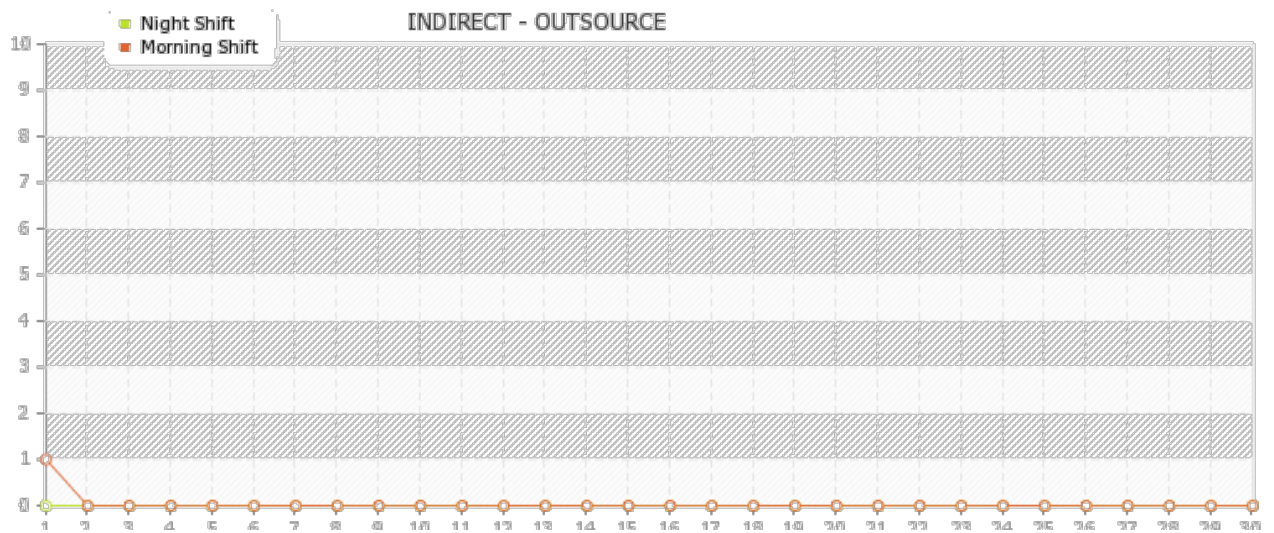

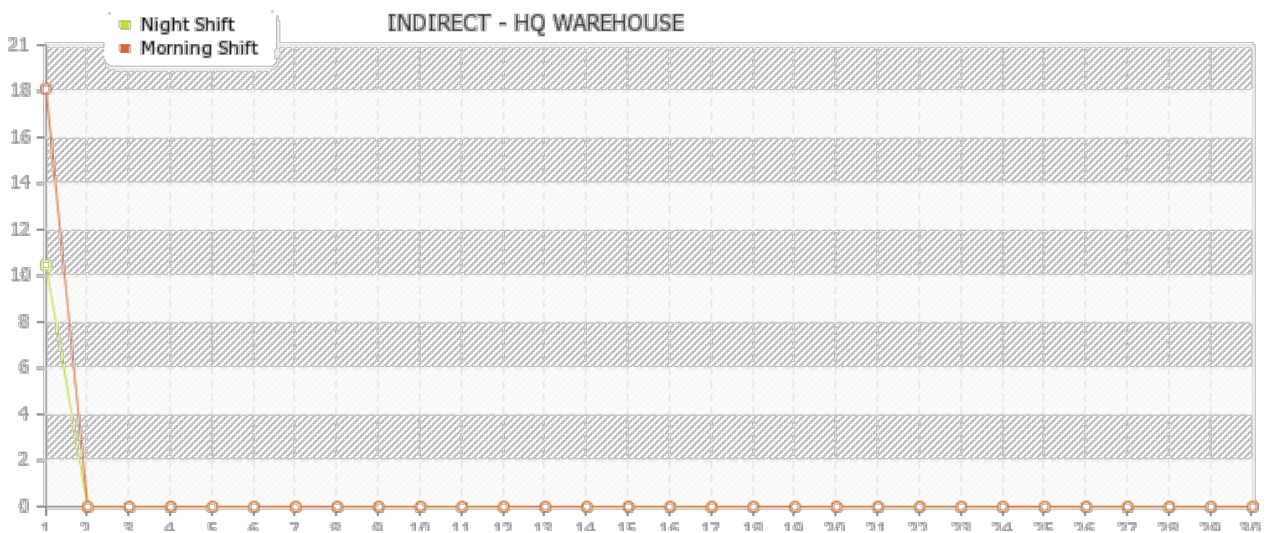
Monthly Attendance for Subang INDIRECT - PRODUCTION CONVERTING



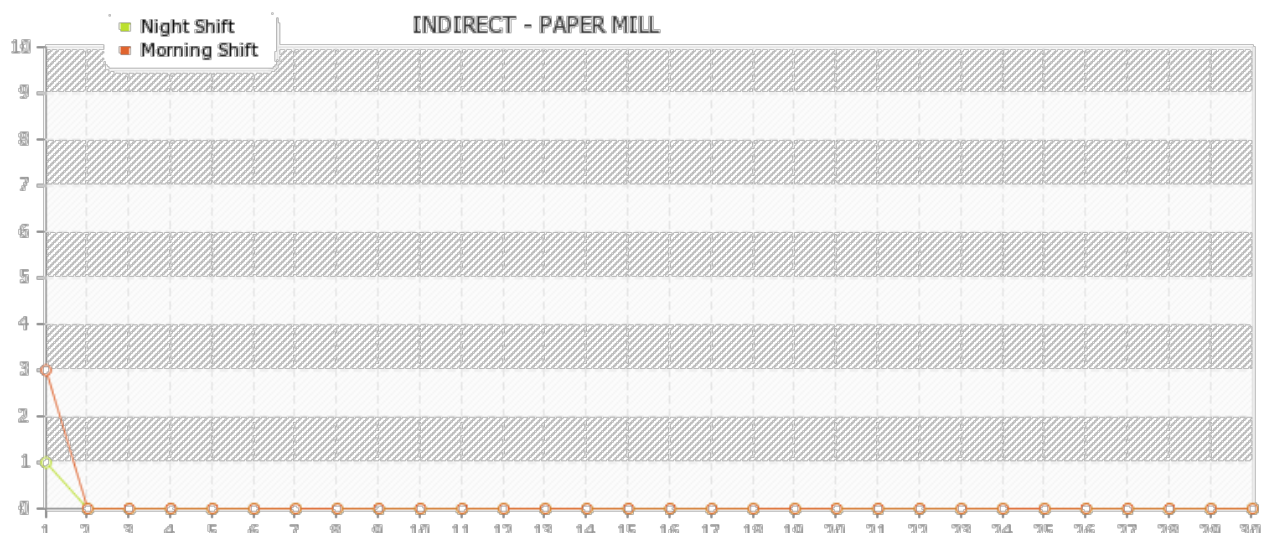

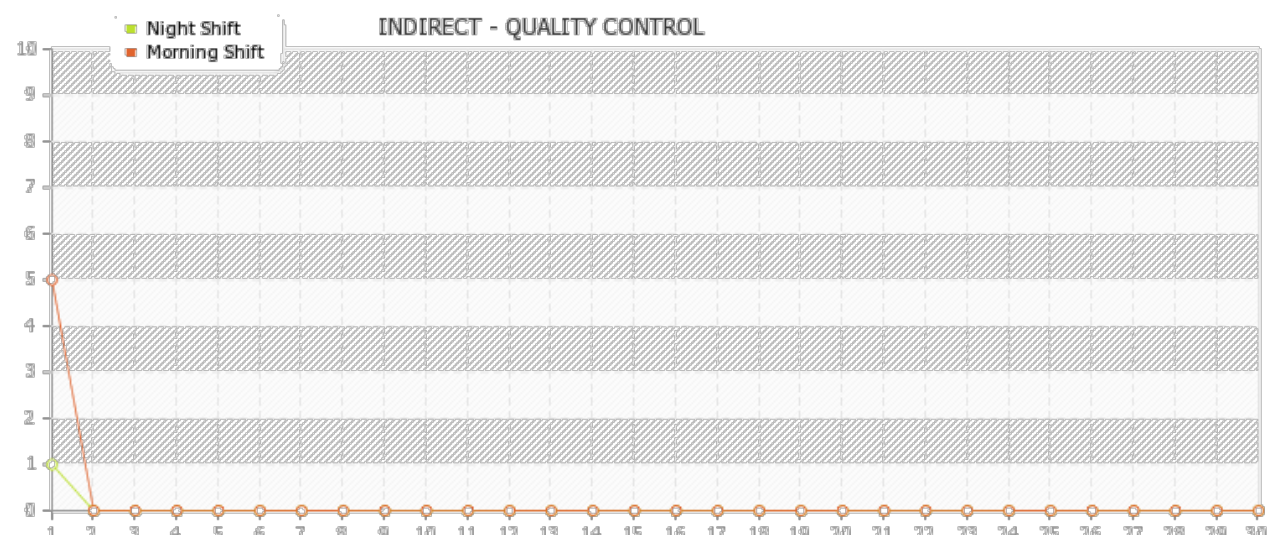
Monthly Attendance for Subang INDIRECT - HQ WAREHOUSE



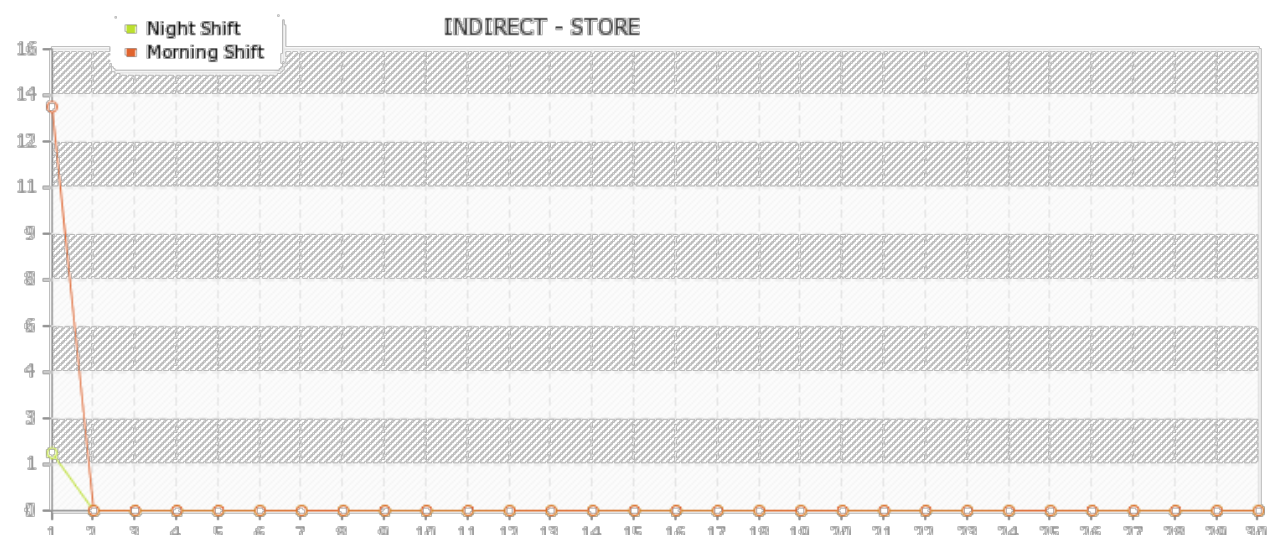

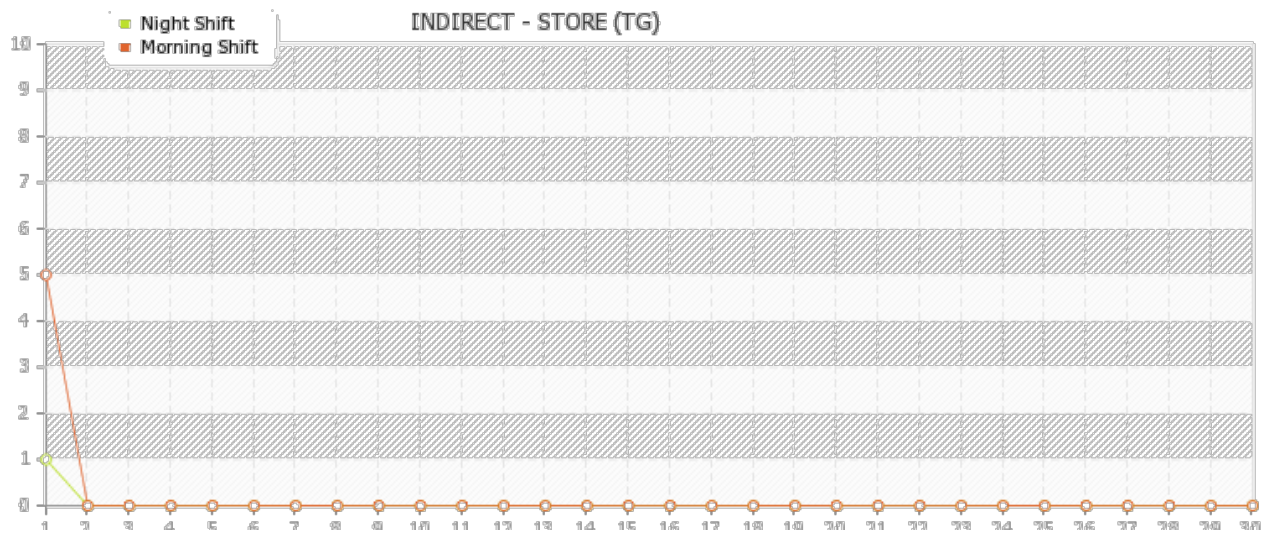

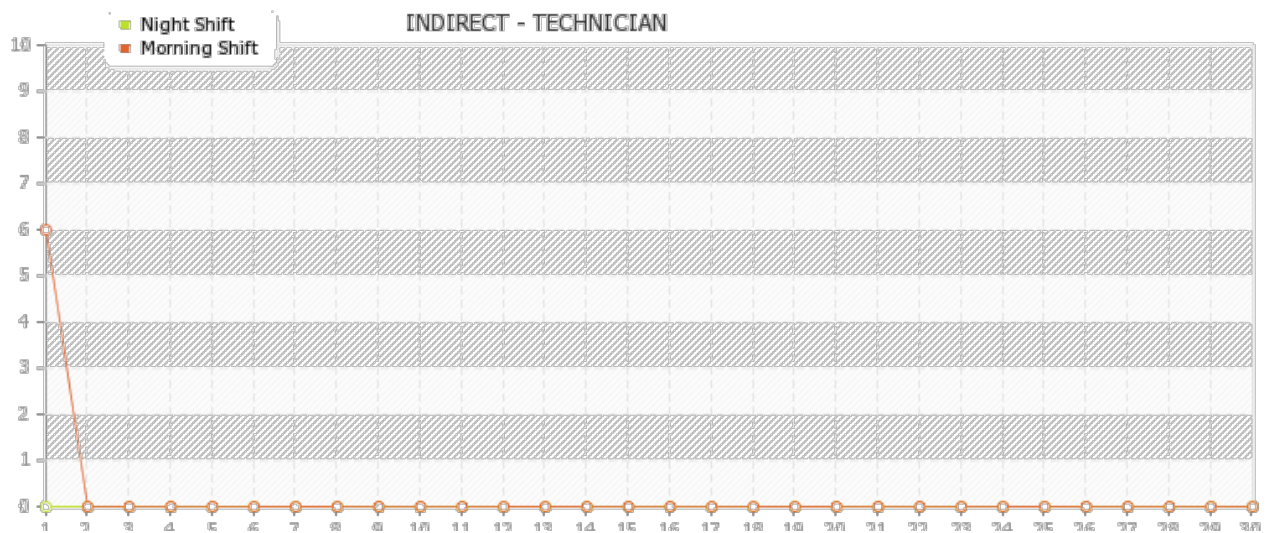

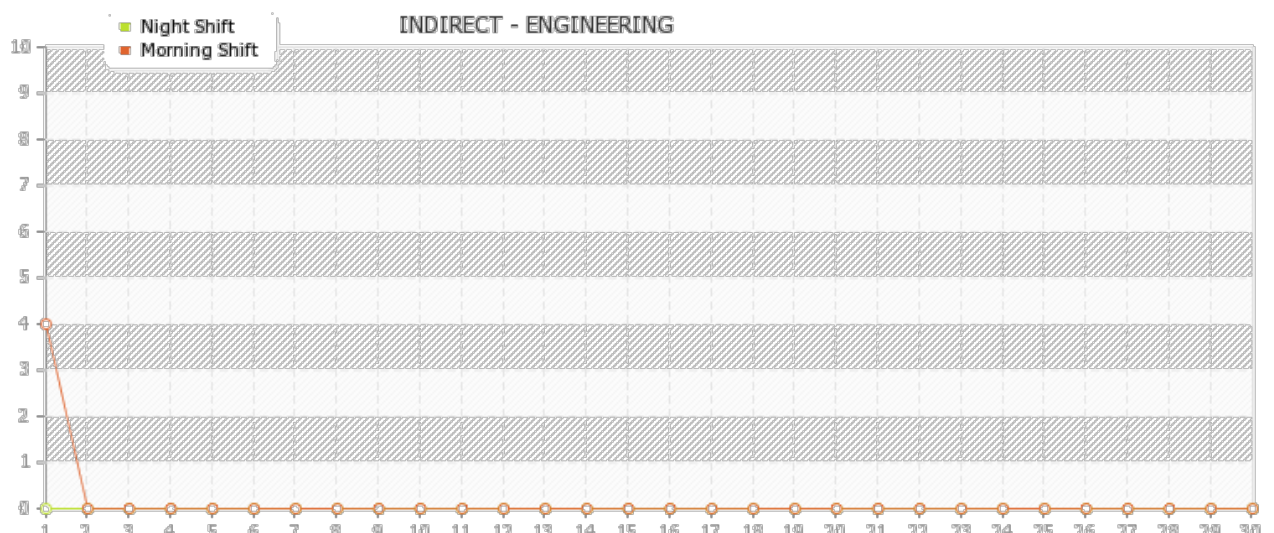

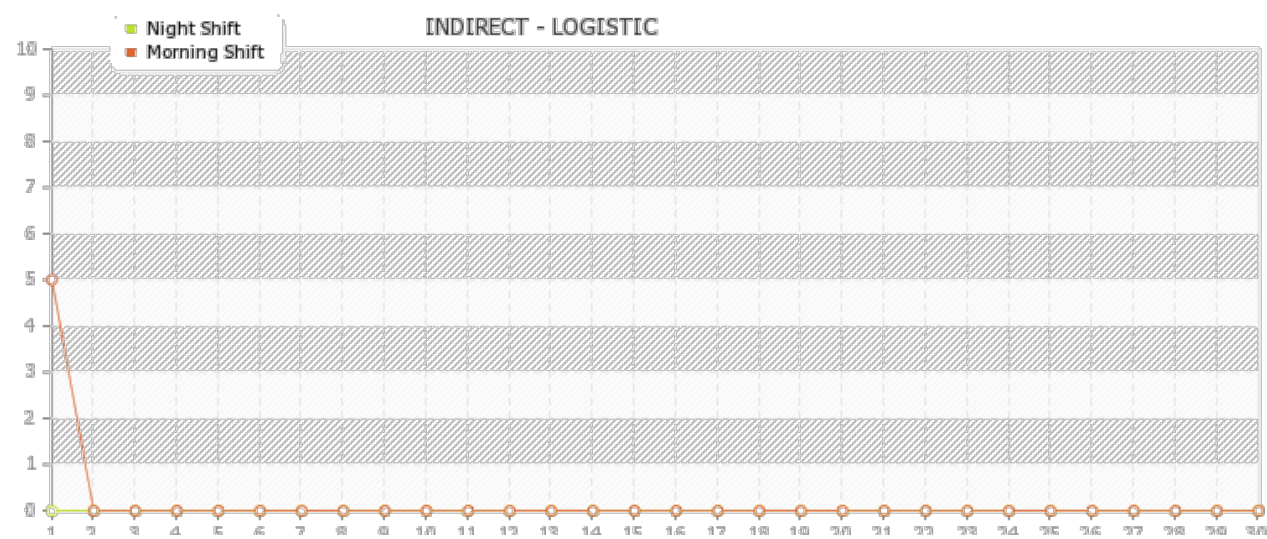

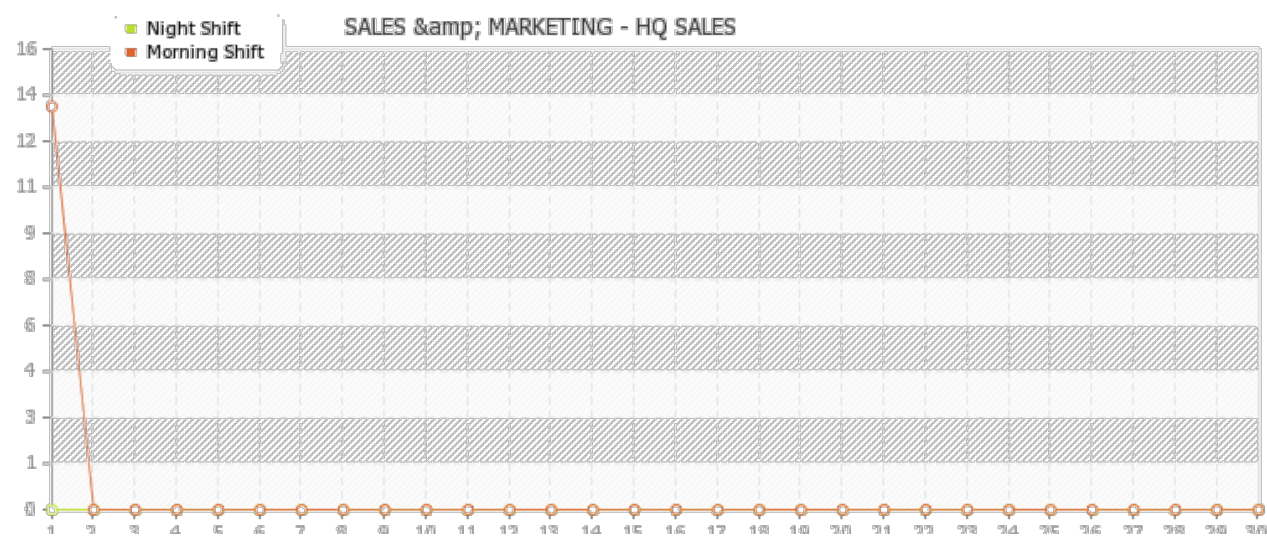


Monthly Attendance for Subang INDIRECT - LOGISTIC

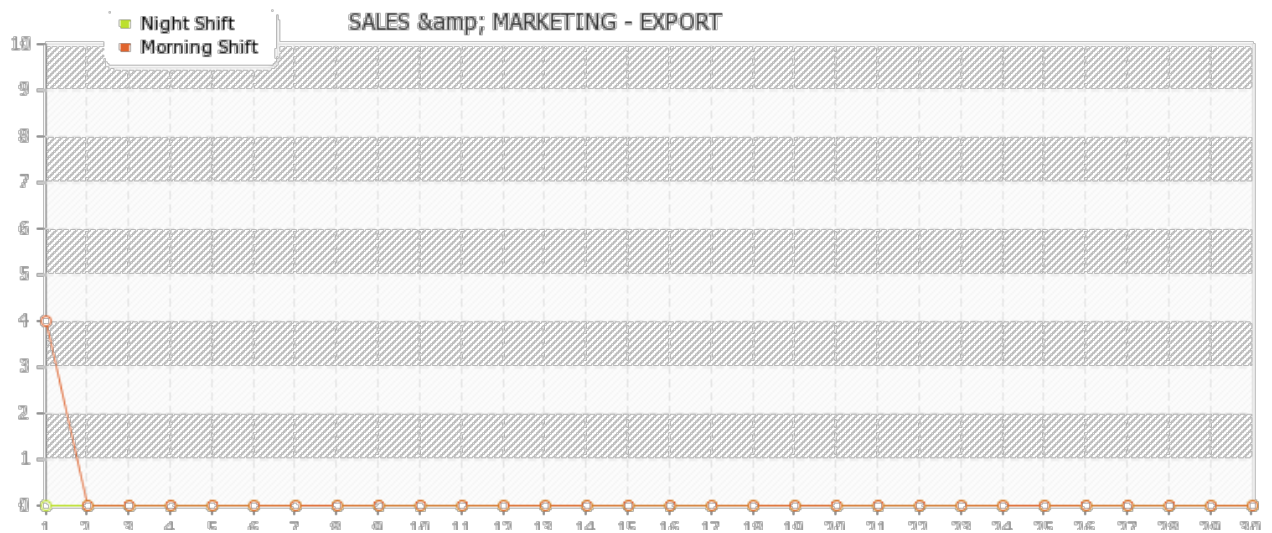

Monthly Attendance for Subang SALES & MARKETING - HQ SALES

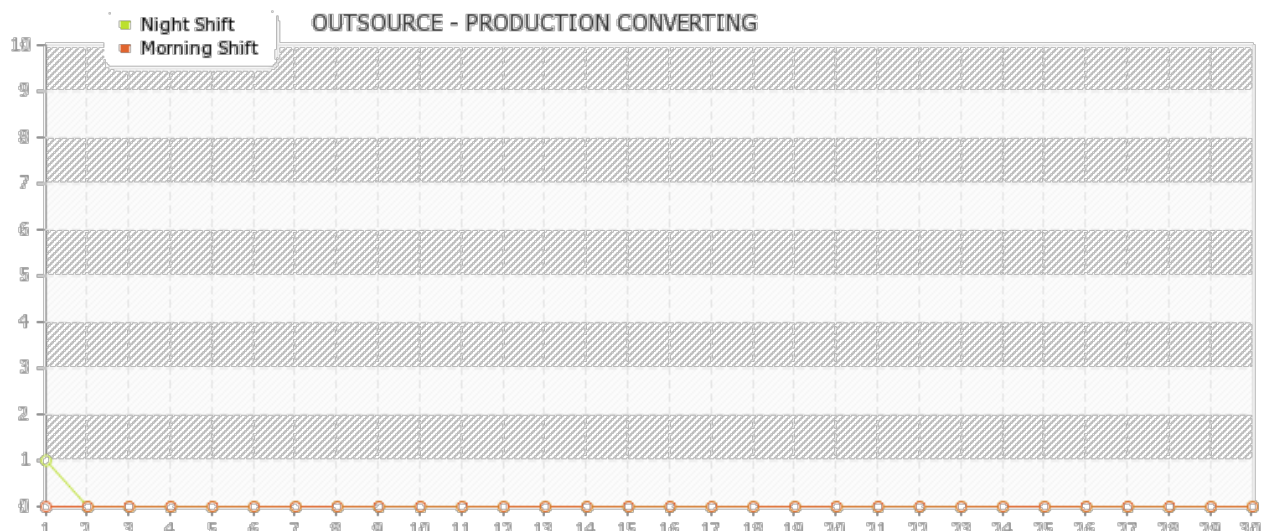


Monthly Attendance for Subang SALES & MARKETING - EXPORT

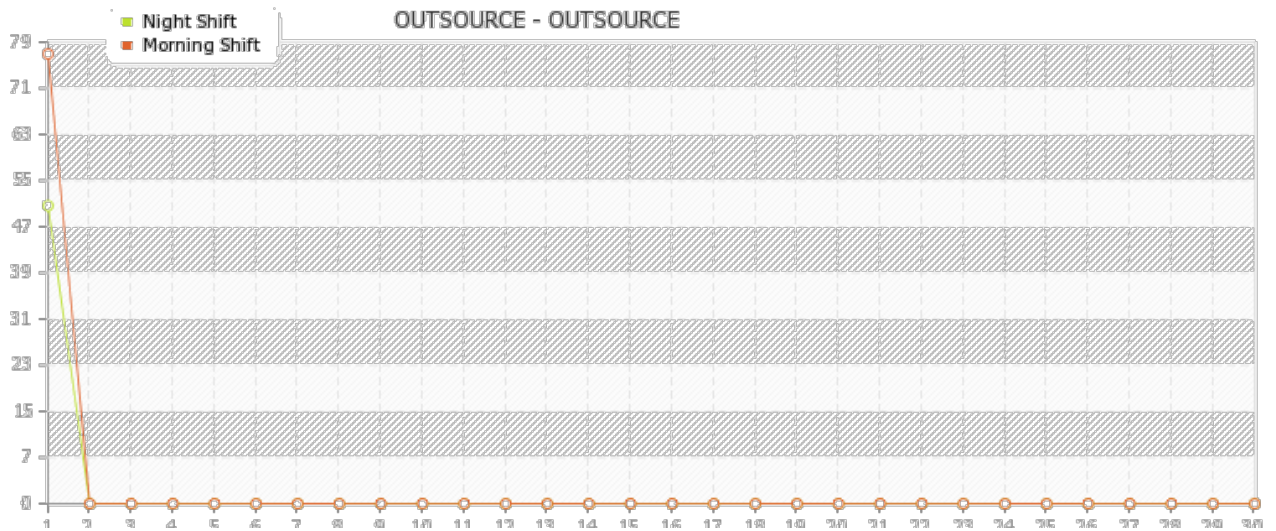

Monthly Attendance for Subang OUTSOURCE - PRODUCTION CONVERTING

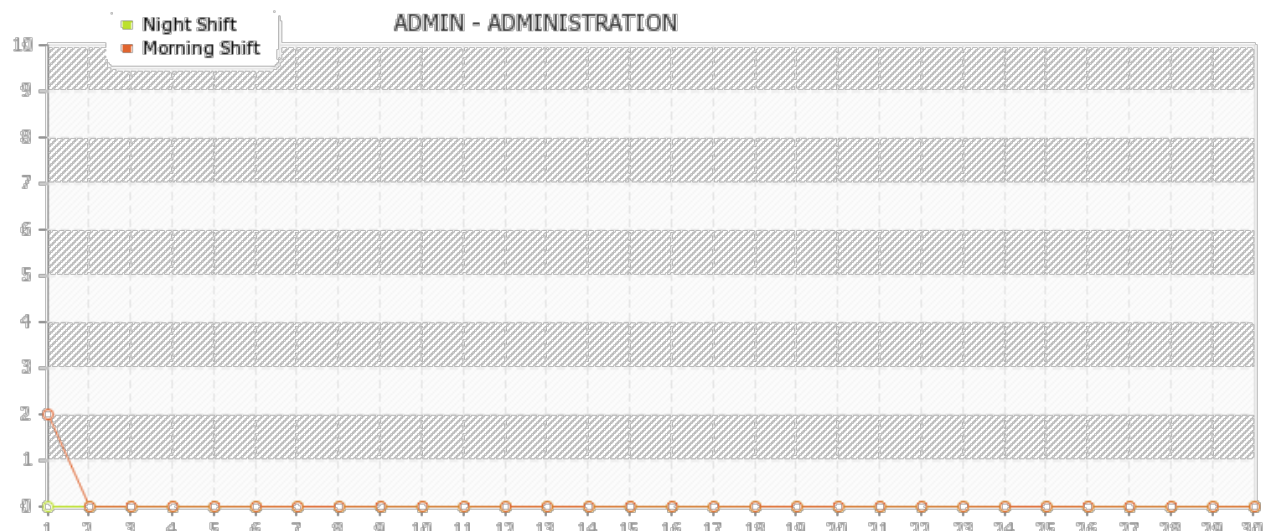

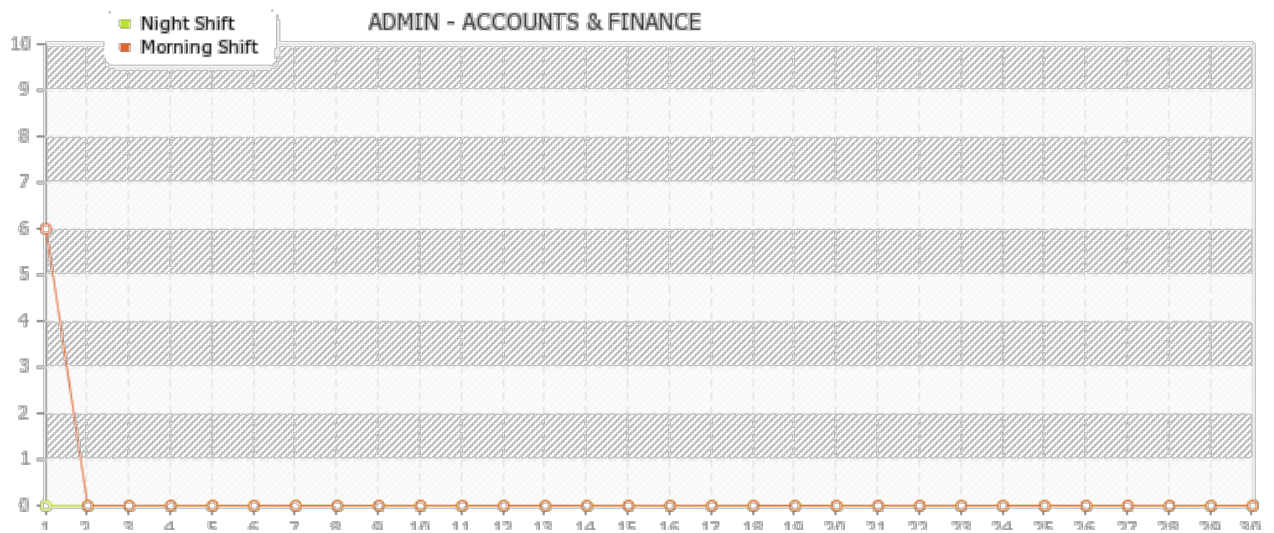

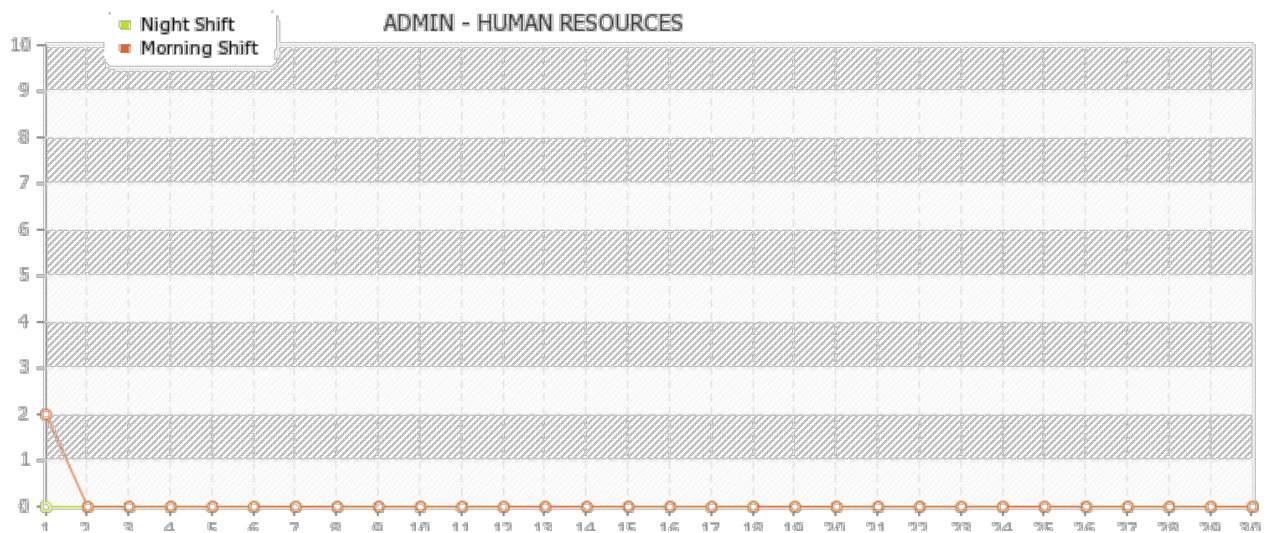

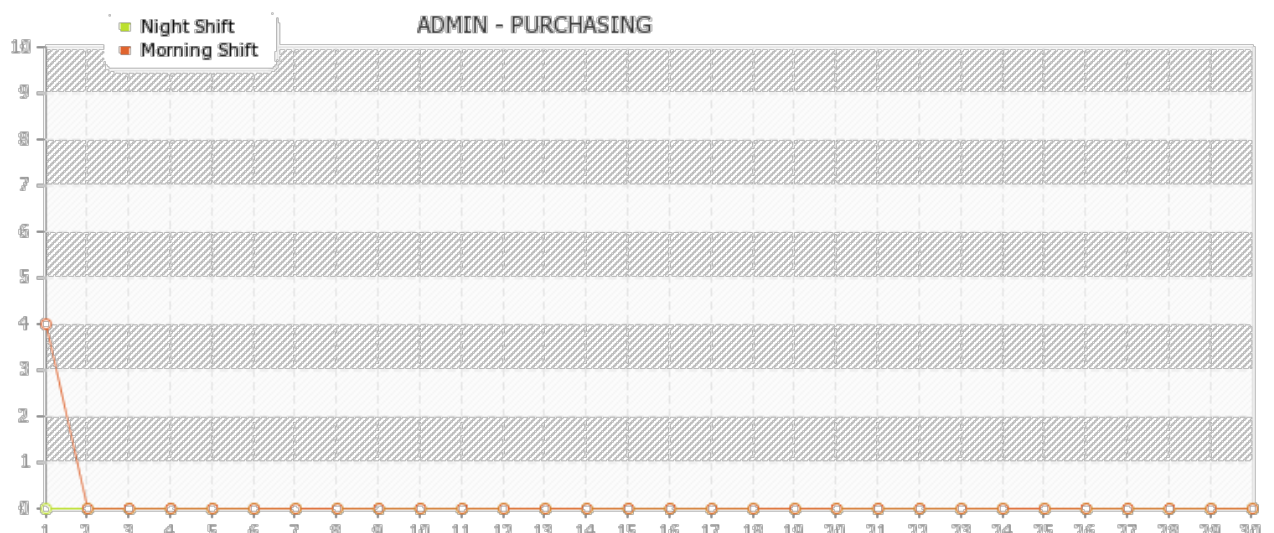
Monthly Attendance for Subang ADMIN - ACCOUNTS & FINANCE



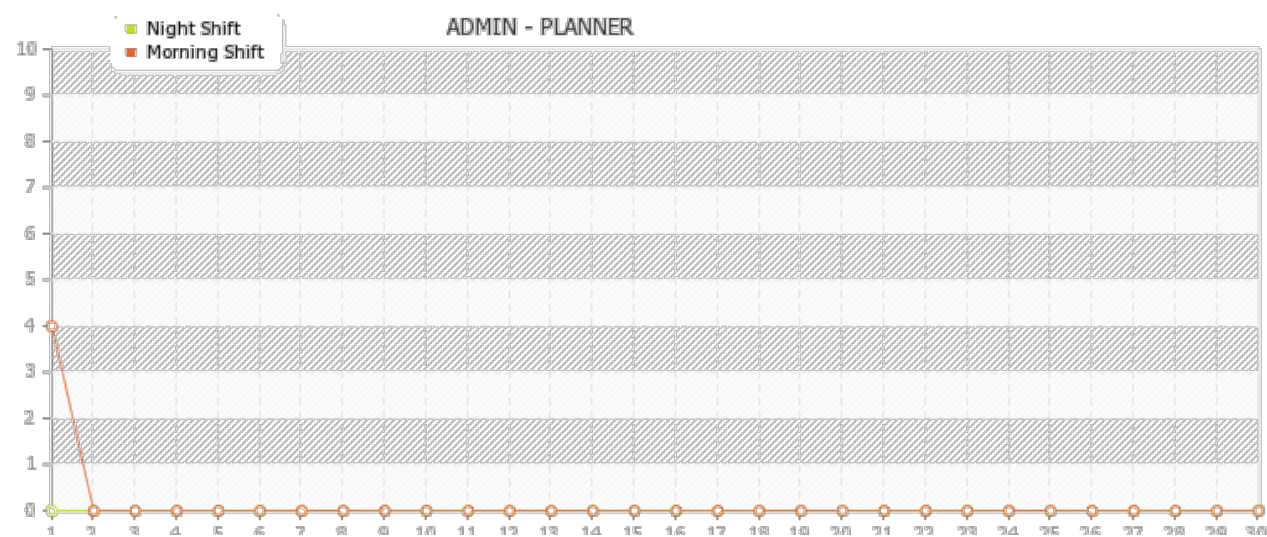

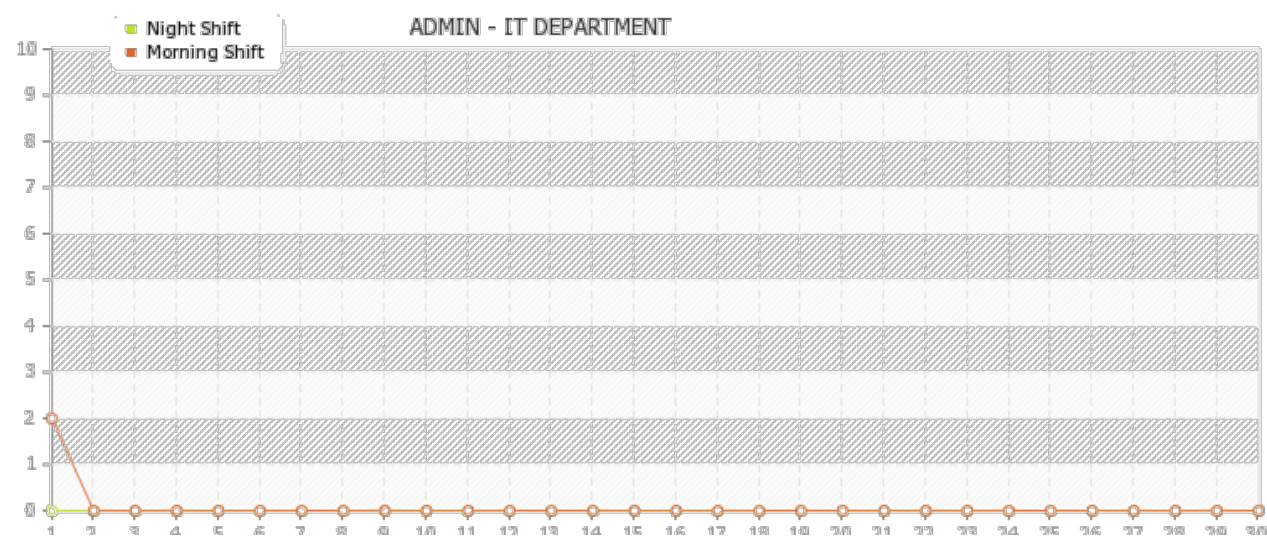
Monthly Attendance for Subang ADMIN - PURCHASING

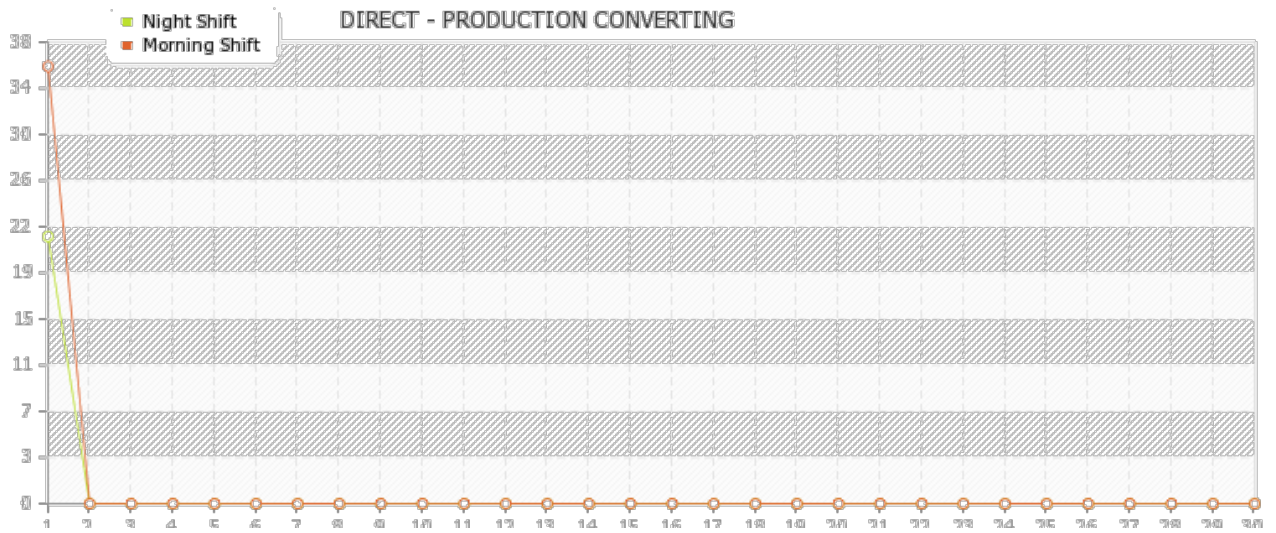


Monthly Attendance for Subang ADMIN - IT DEPARTMENT

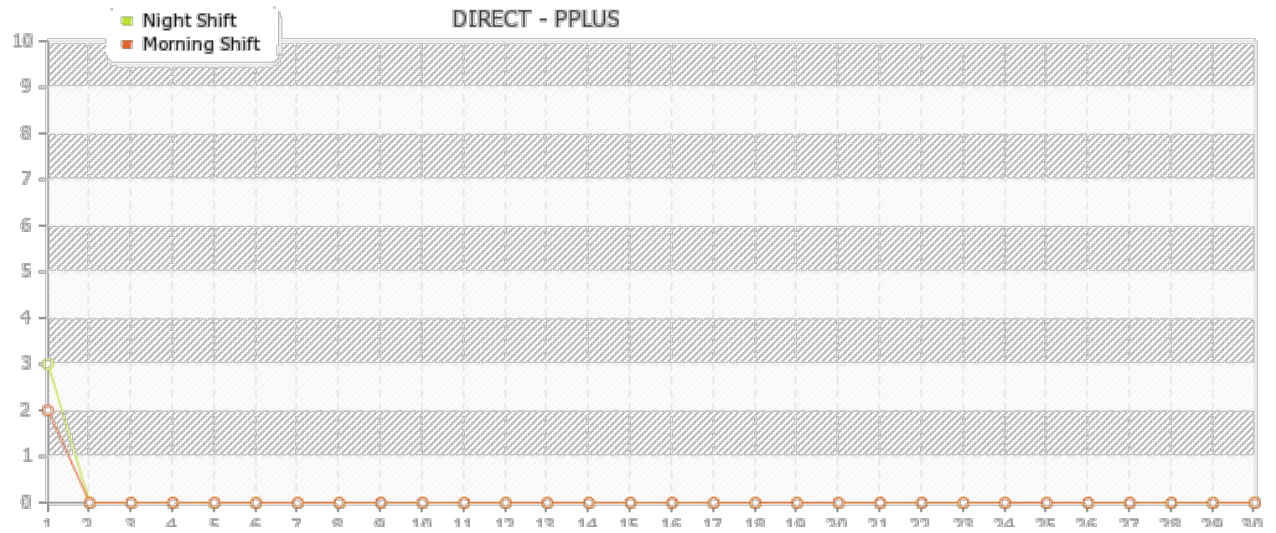

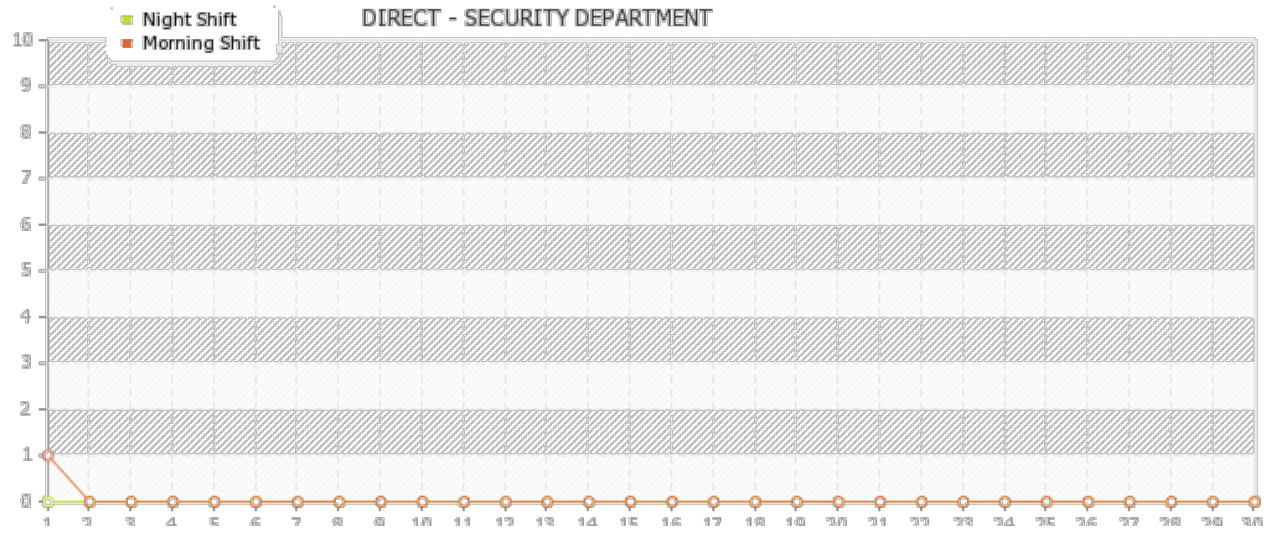
Monthly Attendance for Penang DIRECT - PRODUCTION CONVERTING



Monthly Attendance for Penang DIRECT - PPLUS

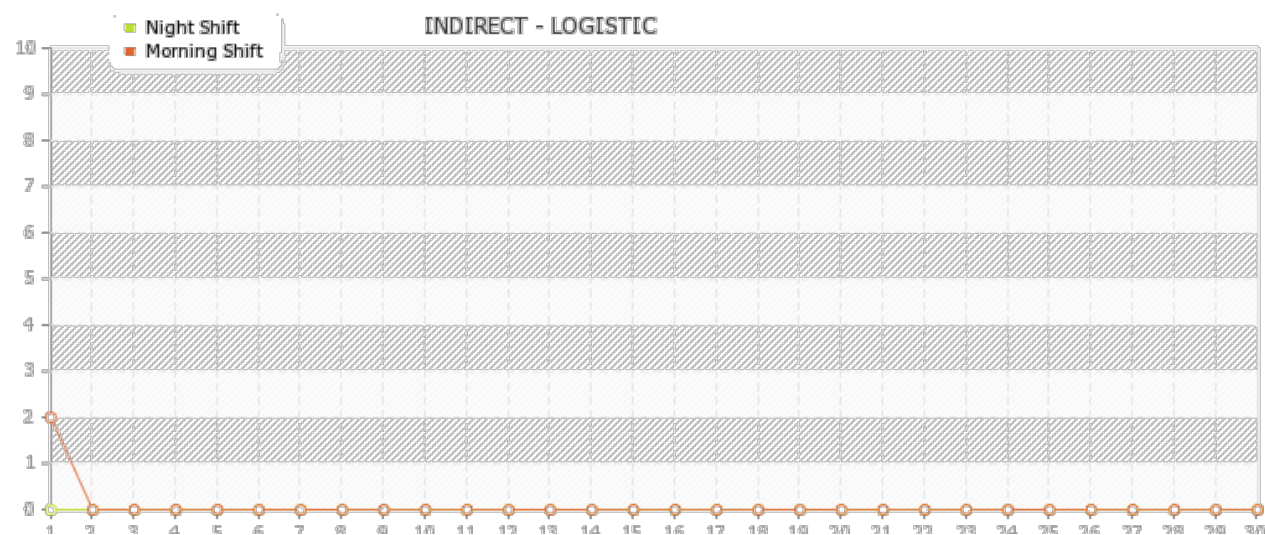


Monthly Attendance for Penang DIRECT - SECURITY DEPARTMENT

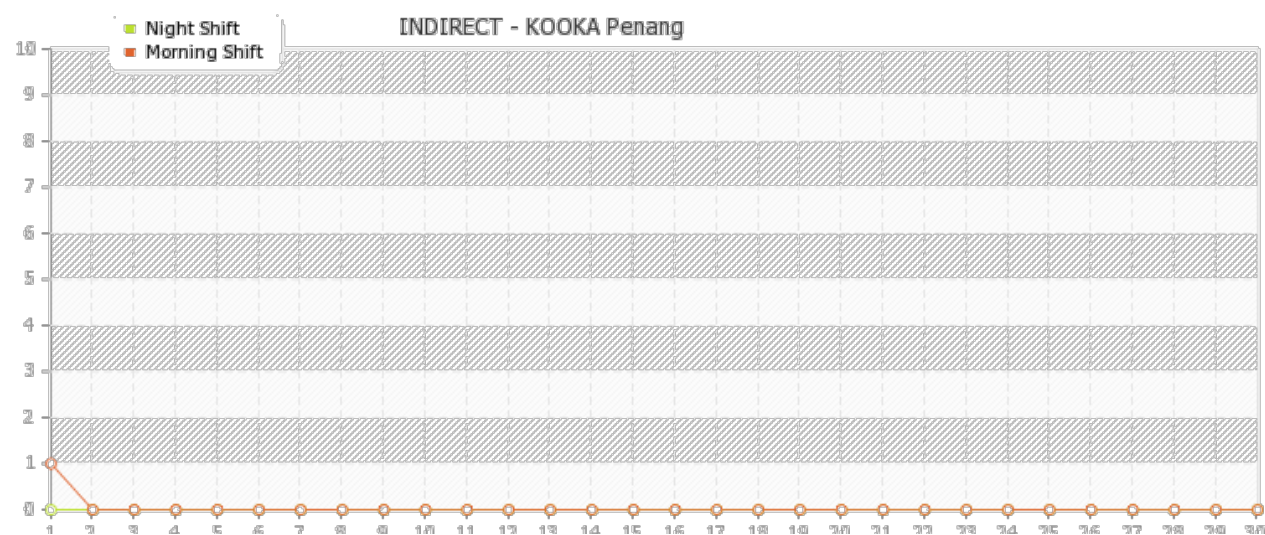

Monthly Attendance for Penang INDIRECT - LOGISTIC

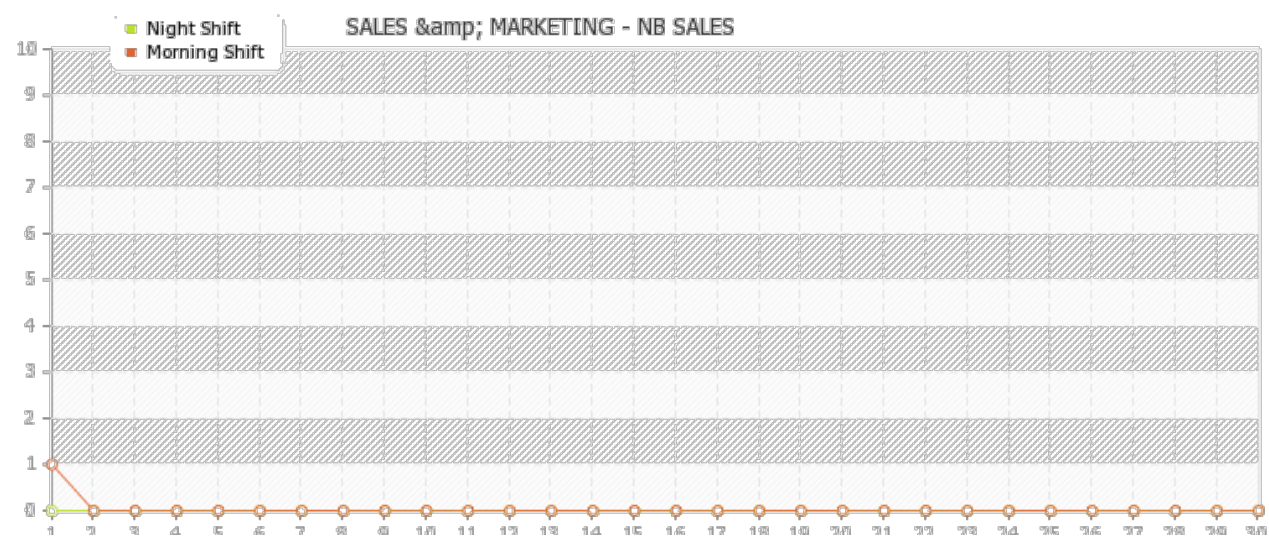


Monthly Attendance for Penang INDIRECT - KOOKA Penang
