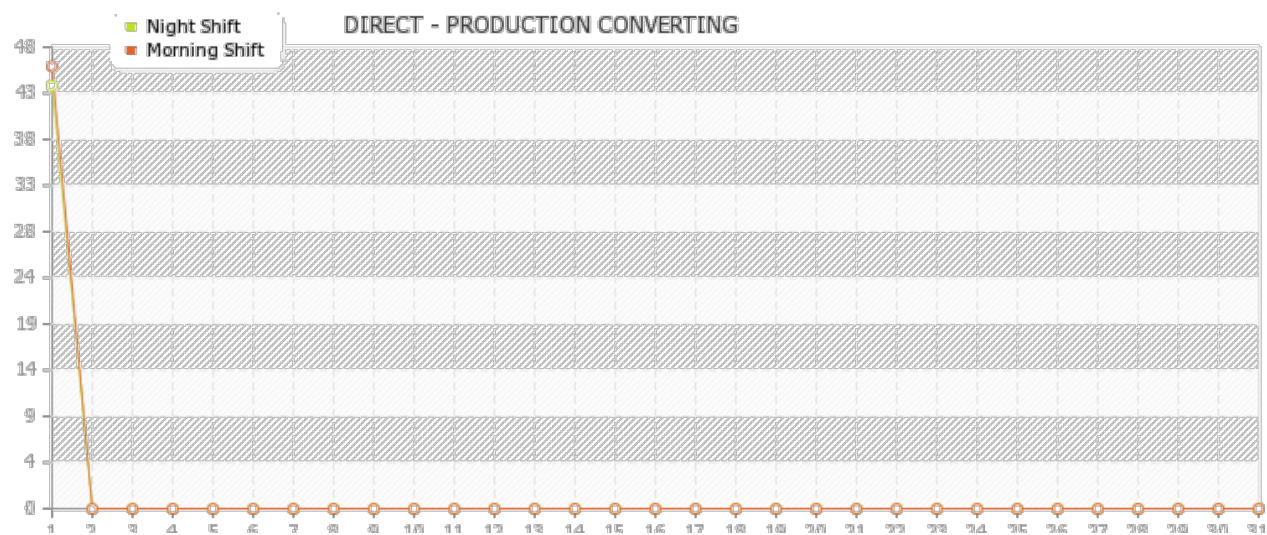

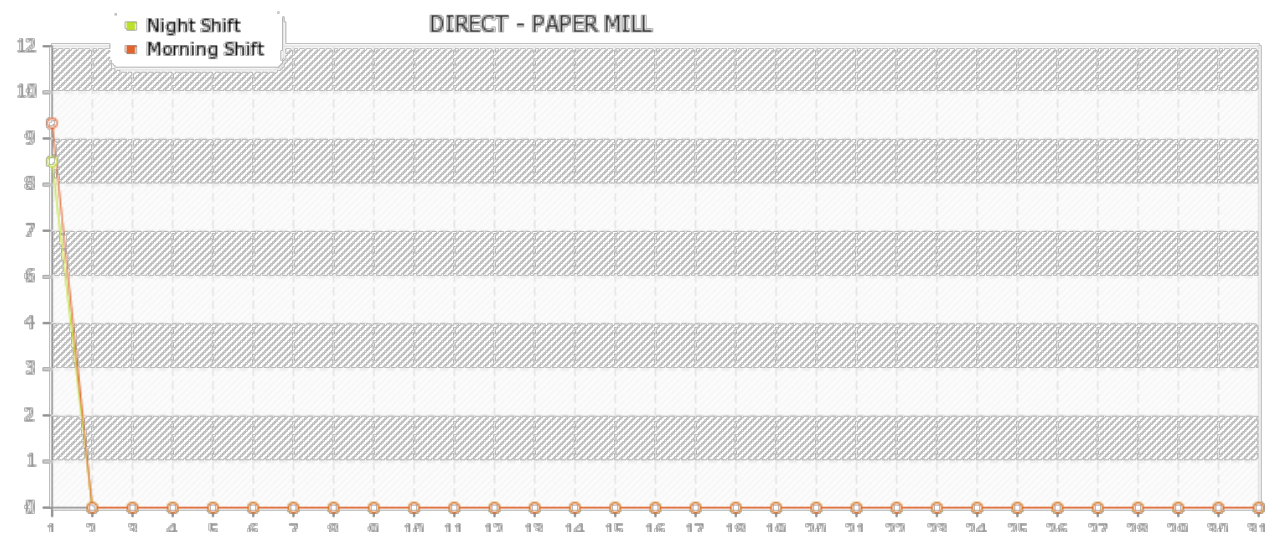

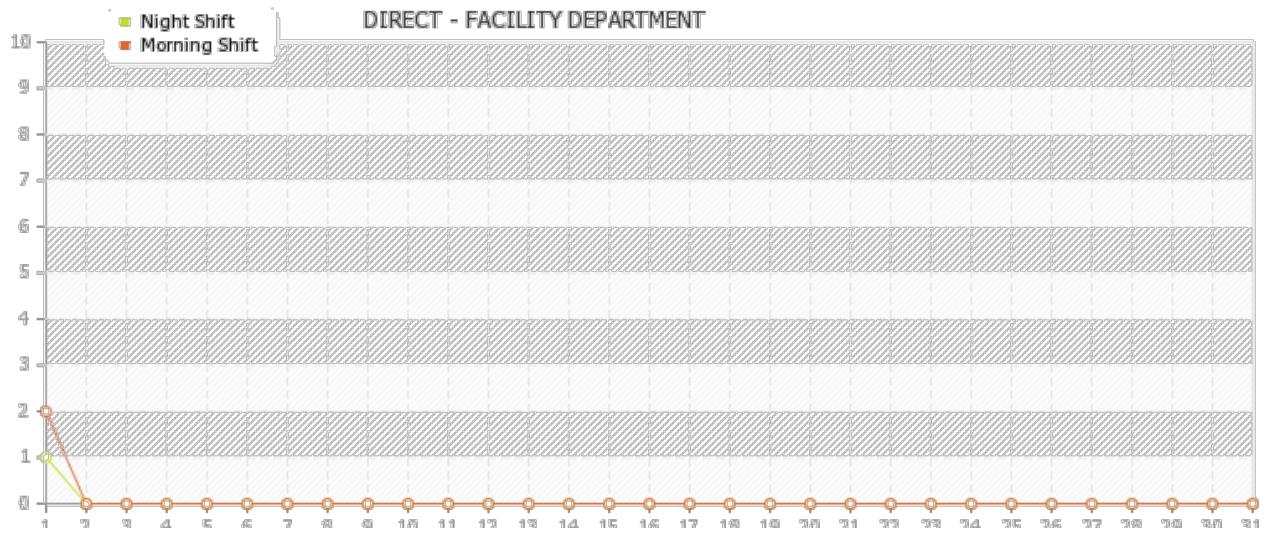
Monthly Attendance for DIRECT - PRODUCTION CONVERTING



Monthly Attendance for DIRECT - PAPER MILL

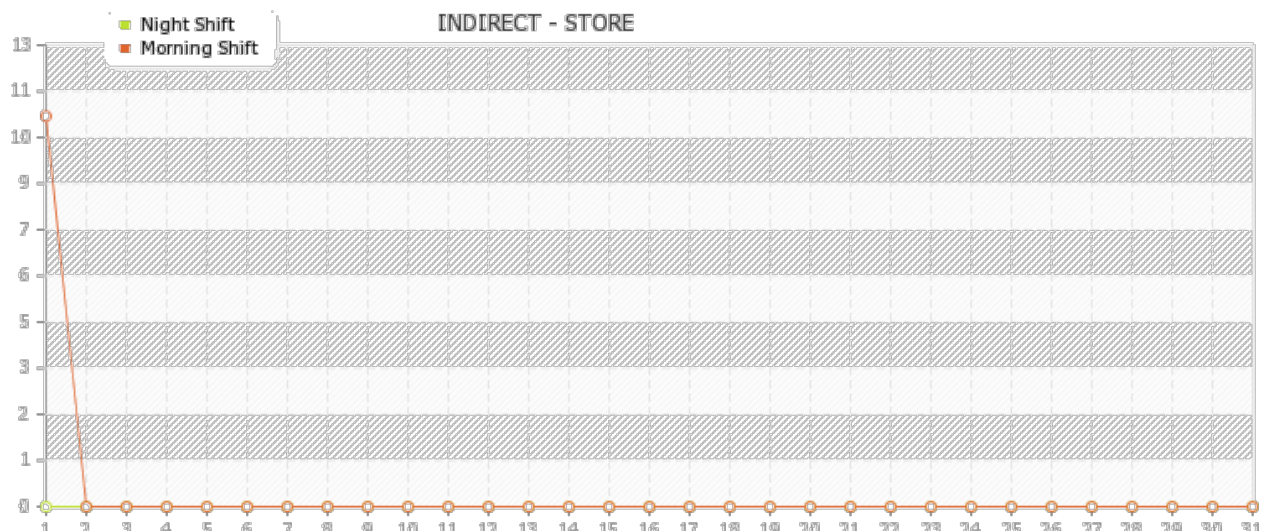


Monthly Attendance for DIRECT - FACILITY DEPARTMENT

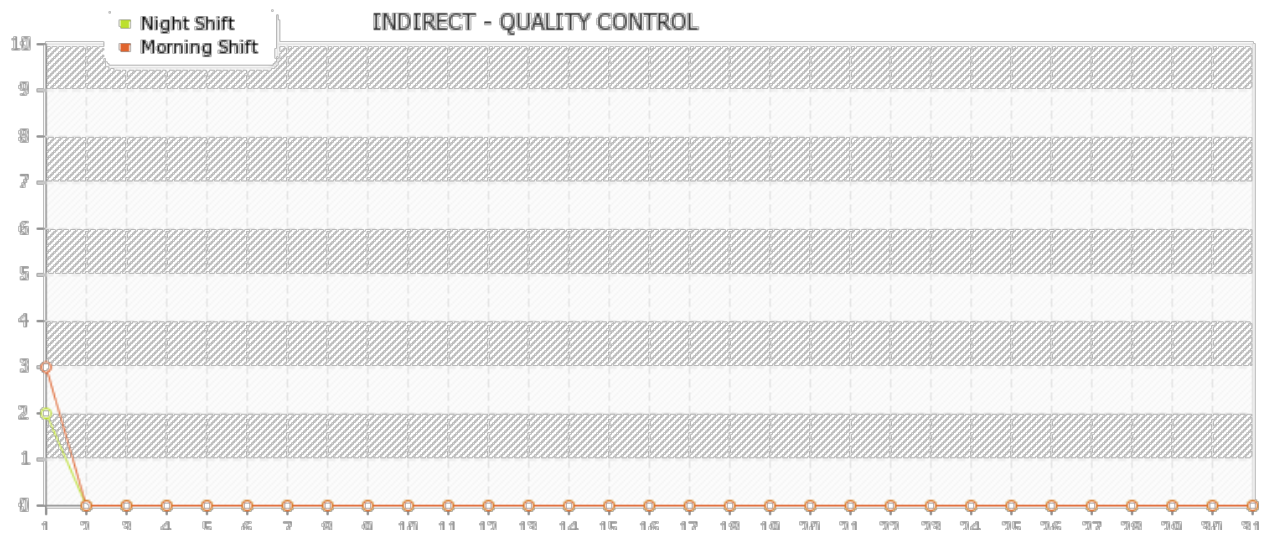

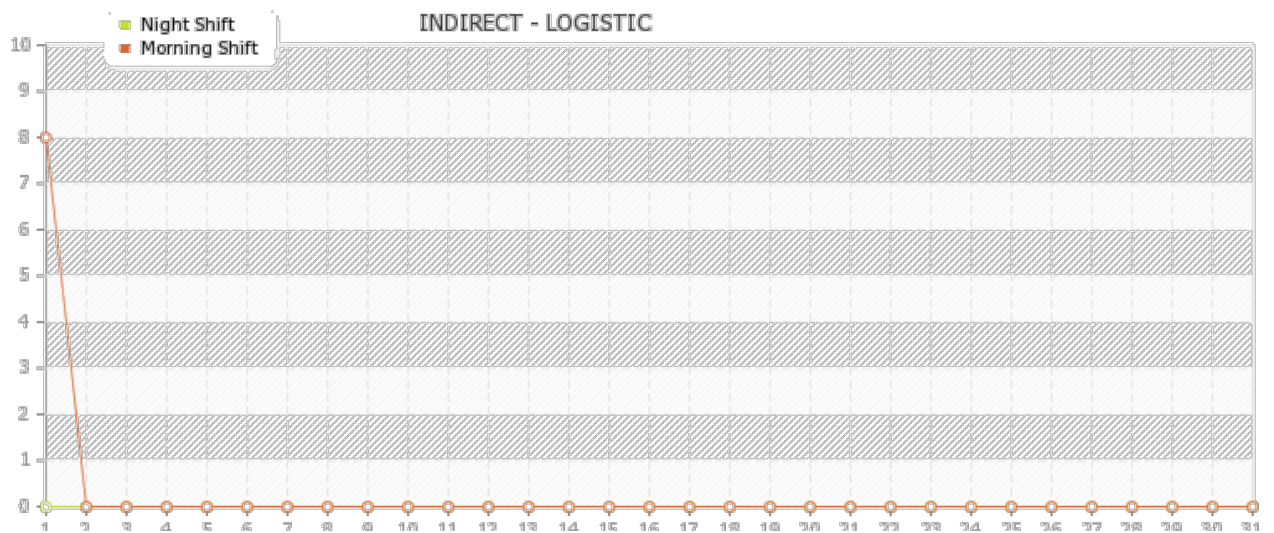
### Monthly Attendance for INDIRECT - STORE



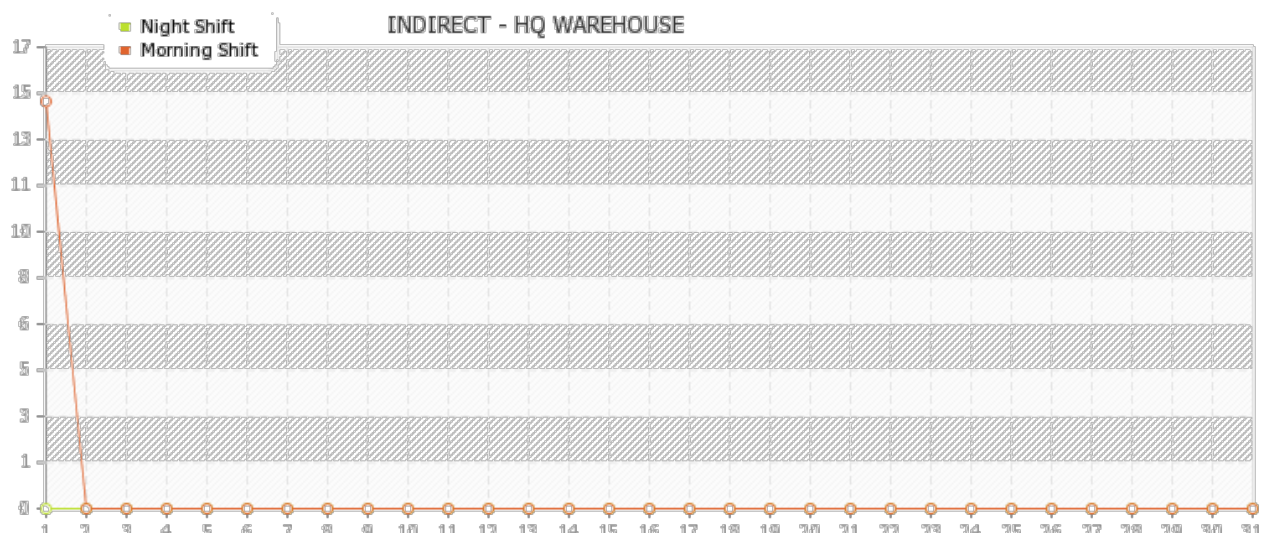
### Monthly Attendance for INDIRECT - QUALITY CONTROL

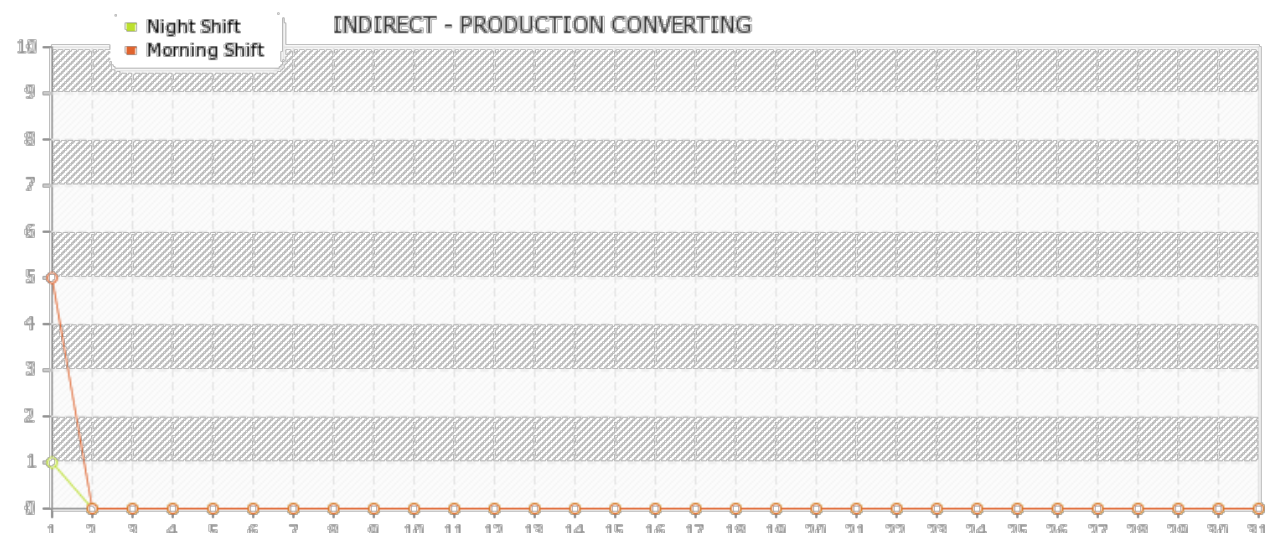

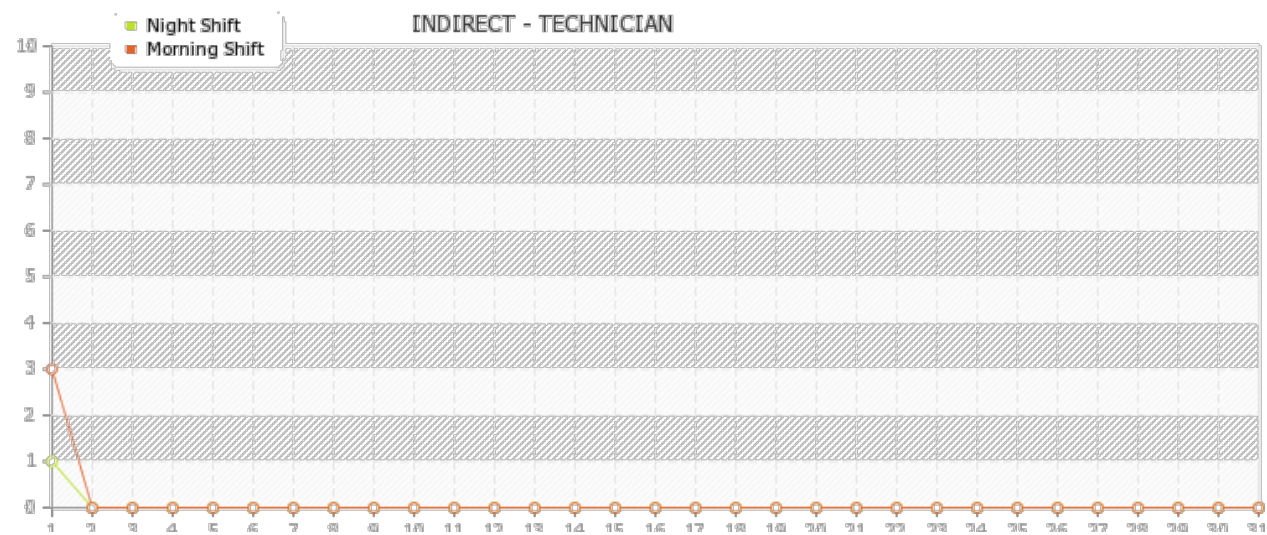




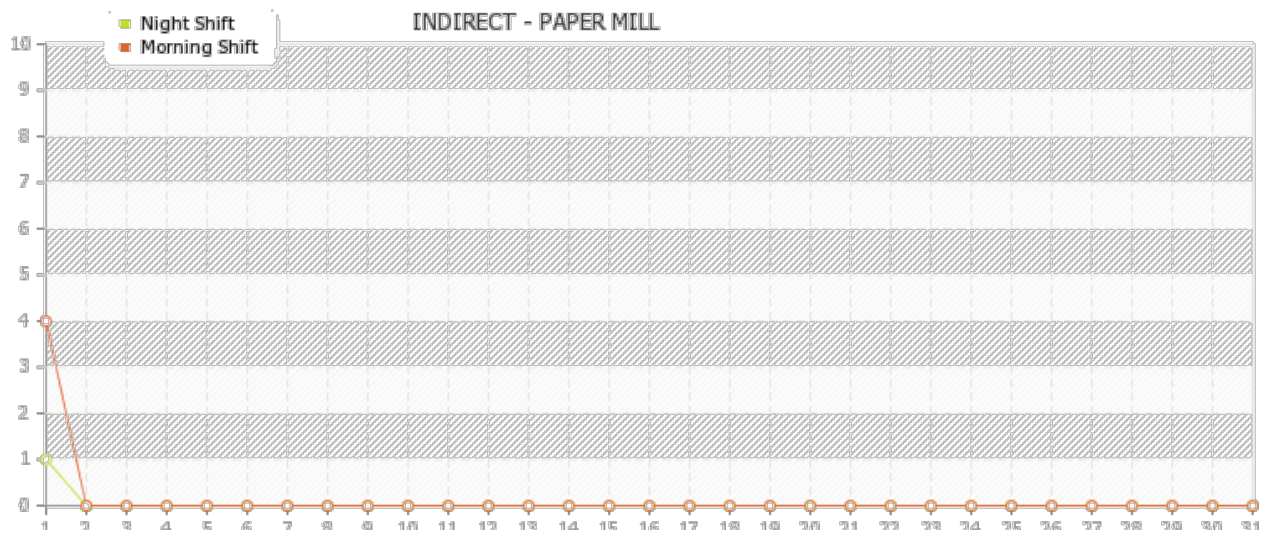
Monthly Attendance for INDIRECT - PRODUCTION CONVERTING



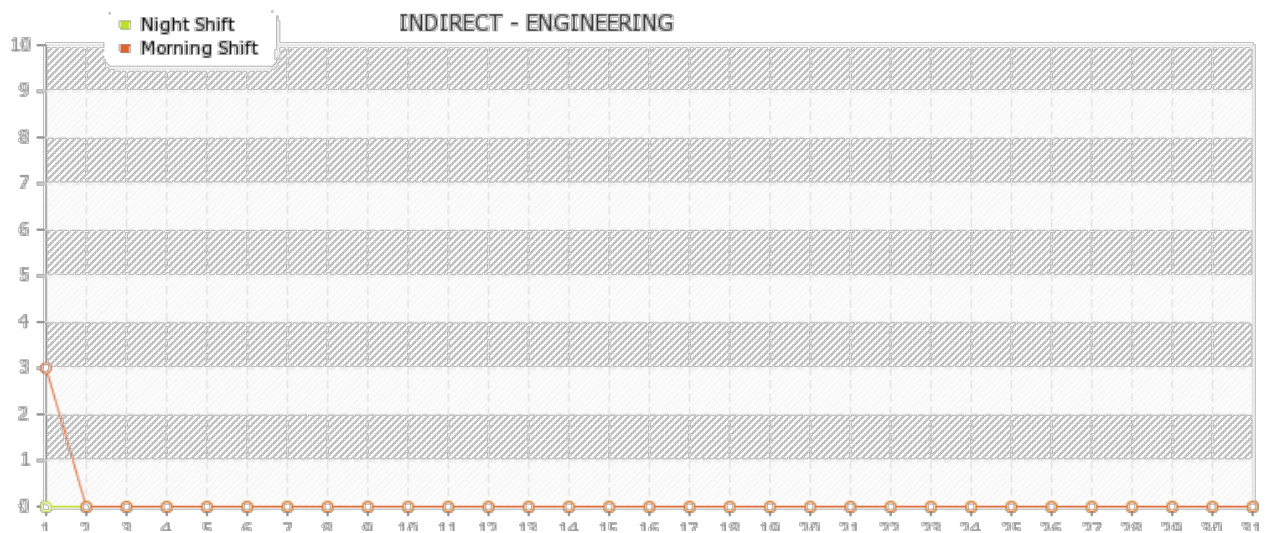
Monthly Attendance for INDIRECT - TECHNICIAN



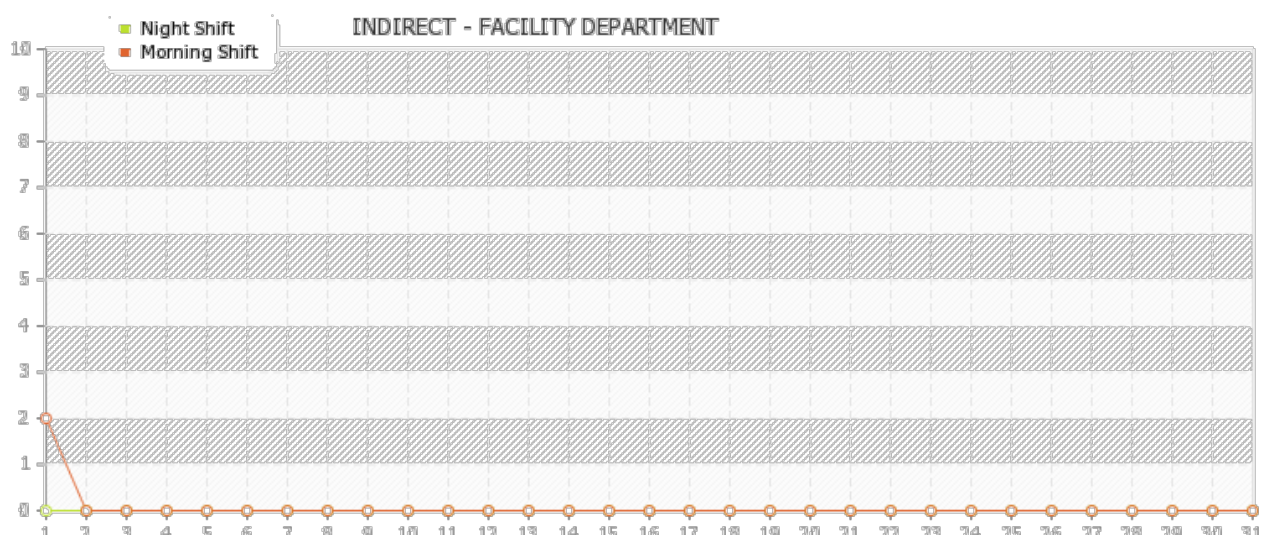
Monthly Attendance for INDIRECT - PAPER MILL



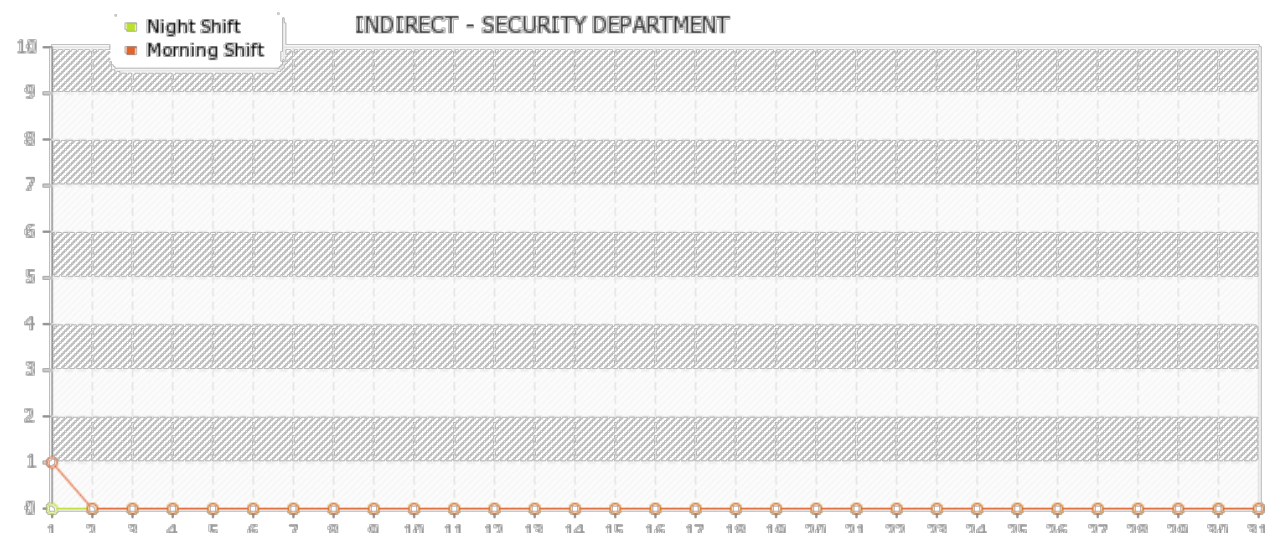

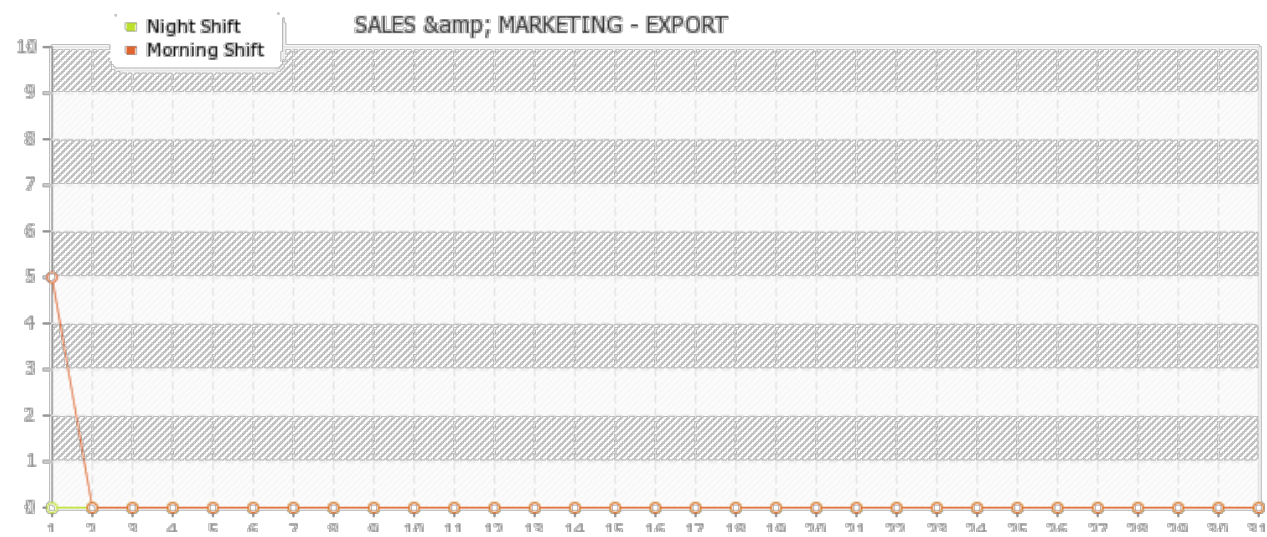


## Monthly Attendance for INDIRECT - SECURITY DEPARTMENT



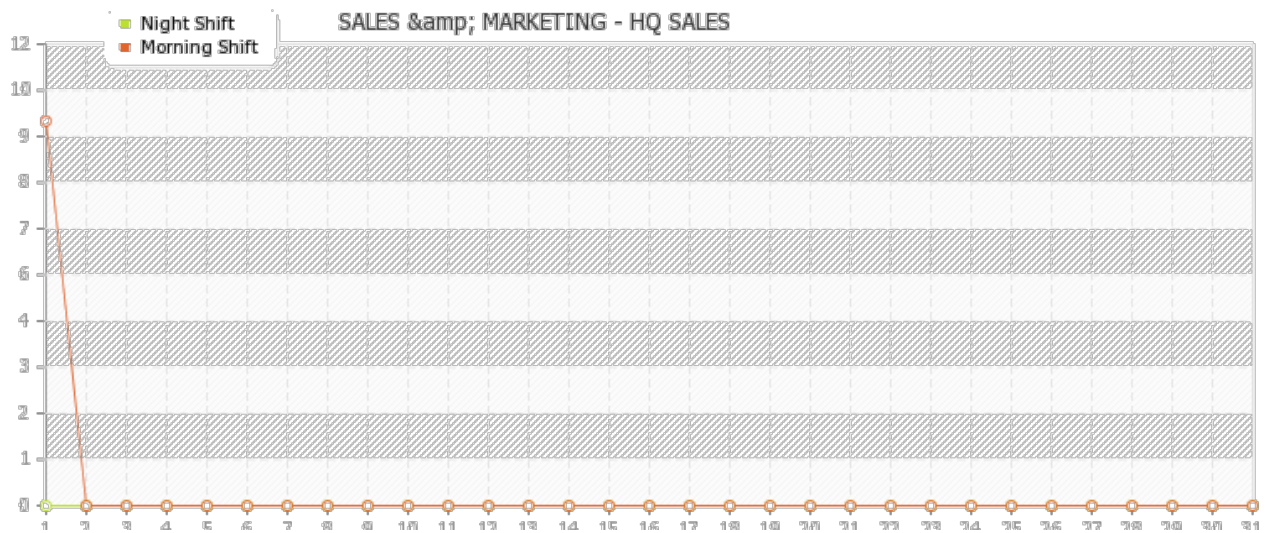

### Monthly Attendance for SALES & MARKETING - EXPORT



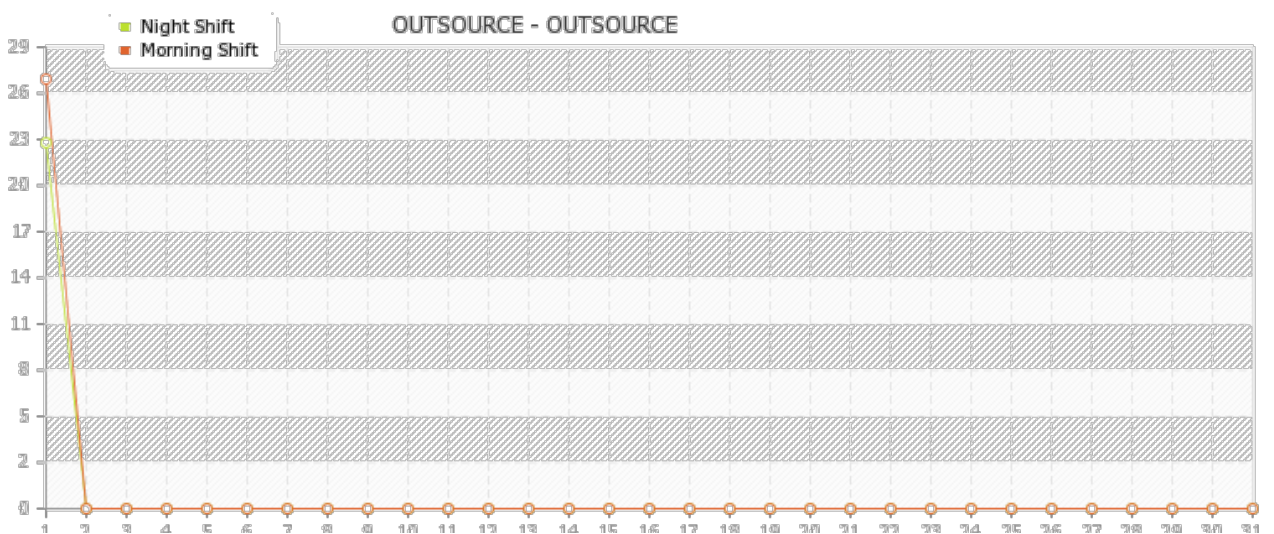
### Monthly Attendance for SALES & MARKETING - HQ SALES

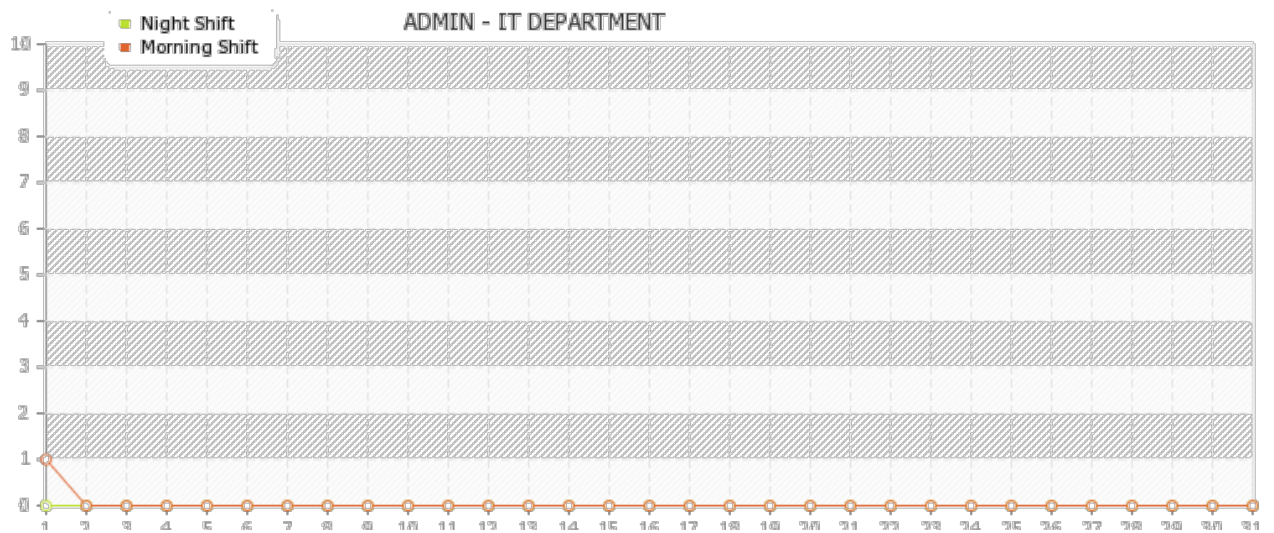

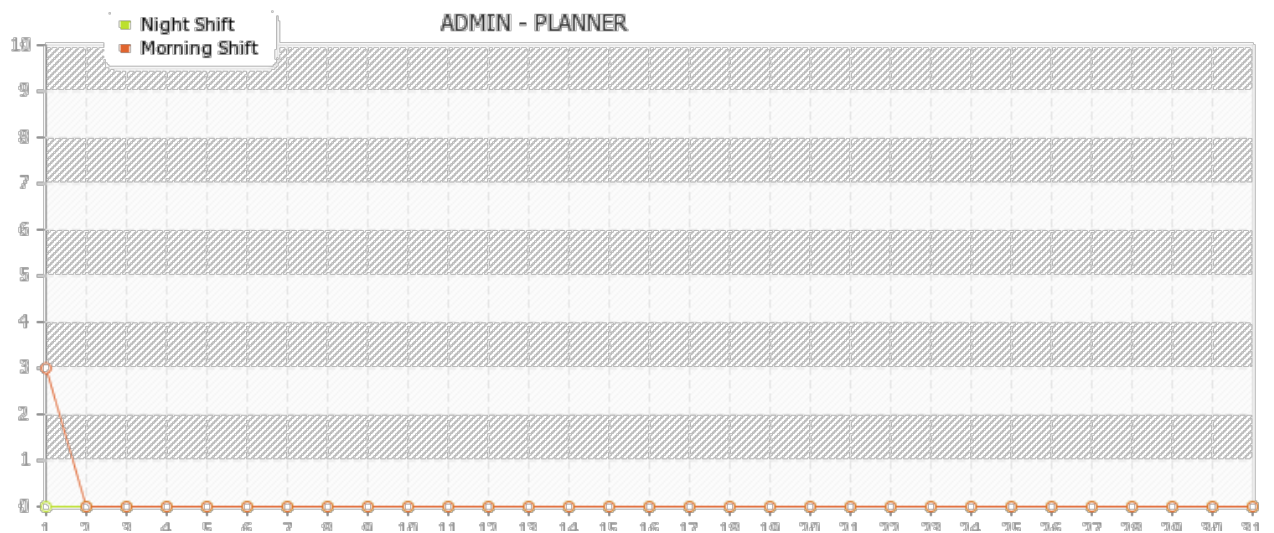

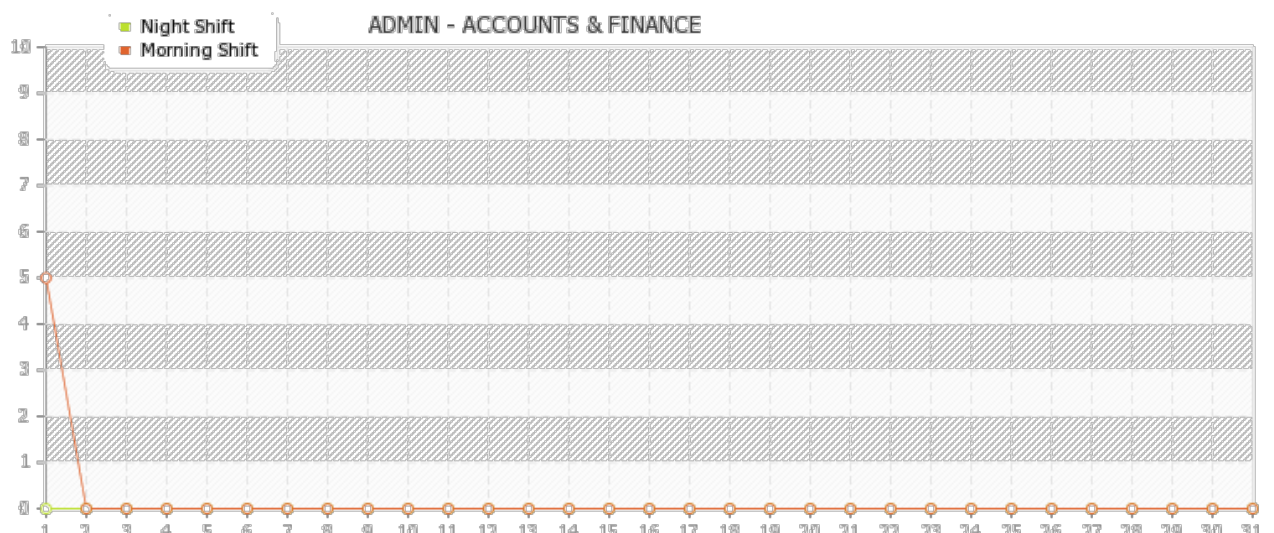

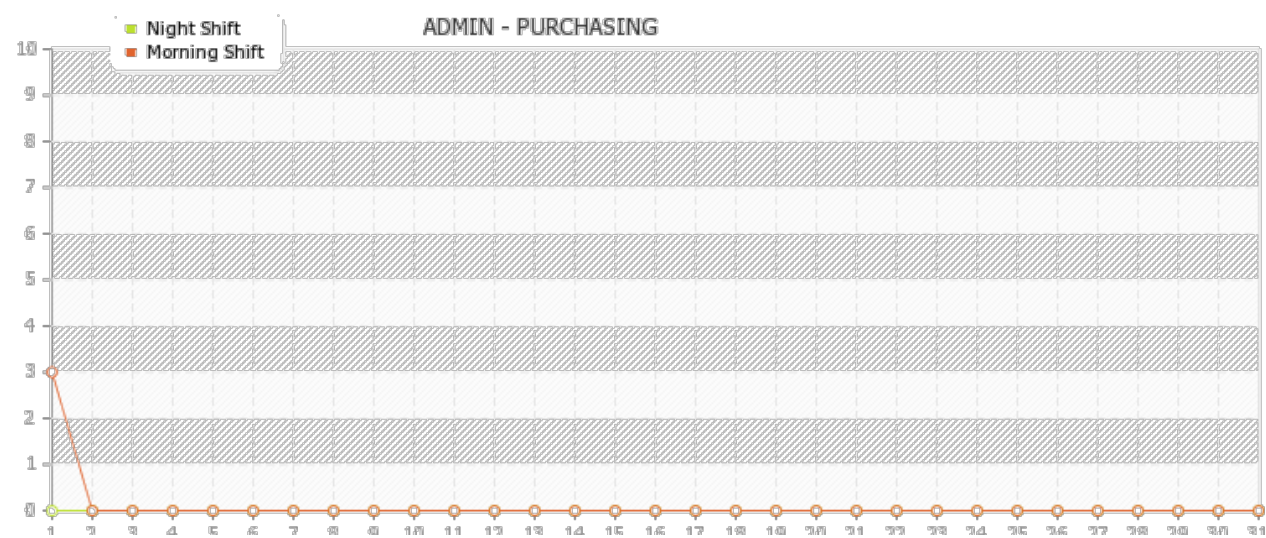
